Re: Request Under Freedom of Information Act

Dear Sir or Madam:

The American Civil Liberties Union of Utah Foundation, Inc. ("ACLU of Utah") submits this Freedom of Information Act ("FOIA") request for records pertaining to the FBI's use of race and ethnicity to conduct assessments and investigations in local communities in Utah, Idaho, and Montana, including all 19 FBI "resident" agencies included within the Salt Lake City Division's jurisdiction (collectively, "FBI Field Office").¹ Specifically, this request seeks records concerning the FBI's implementation of its authority to collect information about and "map" racial and ethnic demographics, "behaviors," and "life style characteristics" in local communities in order to assist the FBI's "domain awareness" and "intelligence analysis" activities. Federal Bureau of Investigation, *Domestic Intelligence and Operations Guide*, December 16, 2008 ("DIOG"), at 32-34.²

In December 2008, the Department of Justice issued revised Attorney General Guidelines, which govern the FBI's conduct in criminal, national security, and counter-intelligence assessments and investigations. That same month, the FBI issued its "Domestic Intelligence Operations Guide" or "DIOG," an internal guide to implementing the Attorney General Guidelines. The DIOG was not made publicly available until September 2009, when the FBI released the guide in heavily-censored form. In January 2010, however, the FBI released through FOIA a less-censored version of the DIOG.

The DIOG contains troubling revelations about the FBI's use of race and ethnicity information in conducting assessments and investigations. Under the DIOG, the FBI is permitted to "identify locations of concentrated ethnic communities in the Field Office's domain" and:

- Collect and analyze racial and ethnic community demographics, including data about “ethnic-oriented businesses or other facilities”;
- Collect and analyze racial and ethnic “behaviors,” “cultural traditions,” and “life style characteristics” in local communities; and
- Map racial and ethnic demographics, “behaviors,” “cultural traditions,” and “life style characteristics” in local communities.

See DIOG at 32-34.

The FBI’s potential “mapping” of local communities and local businesses based on race and ethnicity, as well as its ability to target “ethnic communities” for special collection and mapping of information based on so-called racial and ethnic “behaviors” or “characteristics,” raises significant civil rights and civil liberties concerns.³ Although the DIOG, which purports to authorize this activity, has been in effect for more than a year and a half, the public knows nothing about how the FBI has implemented this troubling authority in the jurisdiction of the FBI Salt Lake City Division.

Requested Records

1. Legal memoranda, procedures, policies, directives, practices, guidance, or guidelines created since December 16, 2007, pertaining to the types of racial and ethnic information—including demographics, behaviors, cultural traditions, and life-style characteristics—about which the FBI can or cannot (a) collect information, (b) map, or (c) otherwise use in the course of assessments and investigations pursuant to the authorities described in the DIOG.
2. Records created since December 16, 2008, describing or listing the types of racial and ethnic information—including demographics, behaviors, cultural traditions, and life-style characteristics—about which the FBI Field Office has collected information or mapped pursuant to the authorities described in the DIOG.
3. Legal memoranda, procedures, policies, directives, practices, guidance, or guidelines created since December 16, 2007, pertaining to the collection of information about or mapping of “ethnically-oriented” businesses or other “ethnically-oriented” facilities pursuant to the authorities described in the DIOG.
4. Records created since December 16, 2008, describing or listing the types of “ethnically-oriented” businesses or other “ethnically-oriented” facilities about which the FBI Field

Office has collected information or mapped pursuant to the authorities described in the DIOG.

5. Legal memoranda, procedures, policies, directives, practices, guidance, or guidelines created since December 16, 2007, pertaining to the specific types of “[f]ocused behavioral characteristics reasonably believed to be associated with a particular criminal or terrorist element of an ethnic community” (DIOG at 33) about which the FBI may collect information or map pursuant to the authorities described in the DIOG.
6. Records created since December 16, 2008, describing or listing the types of “[f]ocused behavioral characteristics reasonably believed to be associated with a particular criminal or terrorist element of an ethnic community” (DIOG at 33) about which the FBI Field Office has collected information or mapped pursuant to the authorities described in the DIOG.
7. Legal memoranda, procedures, policies, directives, practices, guidance, or guidelines created since December 16, 2007, pertaining to the specific types of “behavioral and cultural information about ethnic or racial communities that is reasonably likely to be exploited by criminal or terrorist groups that hide within those communities” (DIOG at 34) about which the FBI may collect information or map pursuant to the authorities described in the DIOG.
8. Records created since December 16, 2008, describing or listing the types of “behavioral and cultural information about ethnic or racial communities that is reasonably likely to be exploited by criminal or terrorist groups that hide within those communities” (DIOG at 34) about which the FBI Field Office has collected information or mapped pursuant to the authorities described in the DIOG.
9. Legal memoranda, procedures, policies, directives, practices, guidance, or guidelines created since December 16, 2007, pertaining to how the FBI is authorized to use the racial and ethnic data it collects pursuant to the authorities described in the DIOG.
10. Records created since December 16, 2008, concerning the number of communities in Utah, Idaho, and Montana about which the FBI Field Office has collected information or mapped racial and ethnic demographics, behaviors, cultural traditions, and life-style characteristics pursuant to the authorities described in the DIOG.
11. Records created since December 16, 2008, listing or describing the communities in Utah, Idaho, and Montana about which the FBI Field Office has collected information or mapped racial and ethnic demographics, behaviors, cultural traditions, and life-style characteristics pursuant to the authorities described in the DIOG.

12. All maps created since December 16, 2008, based on or reflecting racial and ethnic data collected—including demographics, behaviors, cultural traditions, and life-style characteristics—pursuant to the authority described in the DIOG.

Public Interest Fee Waiver Request

We request a waiver of document search, review, and duplication fees on the grounds that disclosure of the requested records is in the public interest because disclosure is “likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in the commercial interest of the requester.” *See* 5 U.S.C. §552(a)(4)(A)(iii); 28 C.F.R. § 16.11(k)(1).

The records sought herein will significantly contribute to public understanding of the FBI’s collection and mapping of racial and ethnic data in local communities. *See* 28 C.F.R. § 16.11(k)(1)(i). Very little is currently known about how the authorities described in the DIOG concerning the collection and mapping of racial and ethnic data have been interpreted or implemented in Utah, Idaho and Montana. Release of the records requested will shed much-needed light on these troubling practices.

The ACLU of Utah plans to disseminate publicly the records disclosed as a result of this FOIA request. The ACLU of Utah routinely obtains information about government activity (including through FOIA), analyzes that information, and widely publishes and disseminates that information to the press and to the public in a variety of ways. For example, the ACLU of Utah regularly publishes a newsletter on average three times a year that reports on and analyzes civil liberties-related current events; this newsletter often includes description and analysis of information obtained through FOIA or other avenues for public information requests. The newsletter is disseminated to approximately 4,000 people.

The ACLU of Utah publishes reports about government activity and civil liberties issues based on its analysis of information derived from various sources, including information obtained from the government through FOIA and other avenues for public information requests. This material is broadly circulated to the public and widely available to everyone for no cost. The ACLU of Utah also publishes and makes available to the general public “know your rights” publications, fact sheets, and educational brochures and pamphlets designed to educate the public about civil liberties issues and government policies that implicate civil rights and liberties.

The ACLU of Utah also publishes, analyzes, and disseminates information through its website: www.acluutah.org. The website addresses civil rights and civil liberties issues in depth, provides features on civil rights and civil liberties issues in the news, and contains many thousands of documents relating to the issues on which the ACLU and the ACLU of Utah are focused. The website includes features on information obtained through the FOIA and other avenues for public information requests.

The ACLU of Utah also creates and disseminates original editorial and educational content on civil rights and civil liberties news through multi-media projects, including videos, podcasts, and interactive features.

Disclosure of the requested records is not in the ACLU of Utah's commercial interest. The records requested are not sought for commercial use and the ACLU of Utah plans to disseminate the information disclosed as a result of this FOIA request to the public at no cost. Thus, a fee waiver would fulfill Congress's legislative intent in amending FOIA. *See Judicial Watch, Inc. v. Rossotti*, 326 F.3d 1309, 1312 (D.C. Cir. 2003) ("Congress amended FOIA to ensure that it be 'liberally construed in favor of waivers for noncommercial requesters.'") (citation omitted).

News Media Status Fee Limitation Request

We also request a waiver of document reproduction fees on the grounds that the ACLU of Utah qualifies as a "representative of the news media" and the records are not sought for commercial use. 28 C.F.R. § 16.11(d). The ACLU of Utah meets the statutory and regulatory definitions of a "representative of the news media" because it is an "entity that gathers information of potential interest to a segment of the public, uses its editorial skills to turn the raw materials into a distinct work, and distributes that work to an audience." 5 U.S.C. § 552(a)(4)(A)(ii); *see also Nat'l Sec. Archive v. Dep't of Defense*, 880 F.2d 1381, 1387 (D.C. Cir. 1989) (finding that an organization that "gathers information from a variety of sources," exercises editorial discretion in selecting and organizing documents, "devises indices and finding aids," and "distributes the resulting work to the public" is a "representative of the news media" for purposes of the FOIA); *cf. ACLU v. Dep't of Justice*, 321 F. Supp. 2d 24, 30 n.5 (D.D.C. 2004) (finding non-profit public interest group to be "primarily engaged in disseminating information").⁴

Courts have found other organizations whose mission, function, publishing, and public education activities are similar in kind to the ACLU's to be "representatives of the news media." *See, e.g., Elec. Privacy Info. Ctr. v. Dep't of Defense*, 241 F. Supp. 2d at 12-15 (D.D.C. 2003) (finding non-profit public interest group that disseminated an electronic newsletter and published books was a "representative of the news media" for purposes of FOIA); *Nat'l Security Archive*, 880 F.2d at 1387; *Judicial Watch, Inc. v. Dep't of Justice*, 133 F. Supp. 2d 52, 53-54 (D.D.C.

In December 2008, the Department of Justice found that the ACLU was a "representative of the news media" for the purposes of FOIA in the context of a request for documents relating to the detention, interrogation, treatment, or prosecution of suspected terrorists.



⁵ Courts have founds these organizations to be "representatives of the news media" even though they engage in litigation and lobbying activities beyond their dissemination of information and public education activities. *See, e.g., Elec. Privacy Info. Ctr.*, 241 F. Supp. 2d at 5; *Nat'l Sec. Archive*, 880 F.2d at 1387; *see also Judicial Watch, Inc.*, 133 F. Supp. 2d at 53-54; *see also Leadership Conference on Civil Rights v. Gonzales*, 404 F. Supp. 2d 246, 260 (D.D.C. 2005) (finding Leadership Conference to be primarily engaged in disseminating information even though it engages in substantial amounts of legislative advocacy beyond its publication and public education functions).
