Historic Primary Election Takes Place Next Week in San Juan County, Utah

On Tuesday June 26th voters in San Juan County, Utah will go to the polls to cast their votes in a historic primary election. This will be the first election using new district boundaries for the county commission and school board. These new districts were created after a lawsuit filed by the Navajo Nation successfully challenged the previous district boundaries.

In addition to newly-drawn districts, a separate lawsuit filed by the ACLU of Utah resulted in a settlement requiring the county to operate three (3) voting locations on the Navajo reservation and one in Monticello for Election Day voting. The settlement also required that Navajo language assistance be available at these voting locations.

Due to the many changes occurring with the June 26th primary election, the ACLU of Utah has complied this information to help residents of San Juan County cast their votes.

About the June 26h Primary Election in San Juan County, Utah

- The June 26th Primary Election will allow for both mail-in ballots as well as in-person voting and voter registration on Election Day—the latter for the first time as a result of a law passed during the 2018 Utah legislative session.
- Primary elections will occur in five county contests: County Commission #1 (Republican), County Commission #3 (Democratic), County Sherriff (Republican), as well as nonpartisan School Board #3, School Board #4. There are additional federal and state elections.
- Mail-in ballots must be postmarked on or before Monday, June 25, 2018
 to the County Clerk's office. Mail-in ballots cannot be mailed on Election
 Day, but they can be dropped off at one of the four voting places listed
 below.
- San Juan County will operate three voting places on the Navajo
 Reservation on Election Day as well as the County Clerk/Auditor's office
 in Monticello.
- Polls will be open on Tuesday, June 26th from 7AM to 8PM for Election Day.
- Navajo language assistance will be provided at each voting location on Election Day.
- San Juan County residents who are NOT registered to vote can still register to vote at a voting place on Election Day and cast a vote.
- If your mail-in ballot was wrong, incomplete, or damaged, you can still vote in-person on Election Day at a voting location.
